Notes-Please read

1. All Juniors under 18 are required to wear an ASTM/SEI, Snell or approved riding helmet at all times when mounted. Minors must be accompanied by an adult in camp and strongly recommended when on the trail.
2. All juniors must have a liability waiver signed by both parents or a guardian. Return signed waiver with entry by mail or bring to the ride. Juniors cannot ride without the signed waivers. No exceptions.
3. ALL RIDERS AND VOLUNTEERS MUST SIGN all Liability Waiver(s) to participate in this ride.
4. Auburn State Recreation Area requires a \$10.00 day use fee. **EXCEPTION:** If you have a valid California State Parks Poppy Pass or a valid Golden Poppy Pass, you are exempt. **YOU MUST DISPLAY YOUR PASS** hanging from your rear-view mirror or on your dash or a \$10.00 fee will apply. Passes will be in your rider packets. Pick up rider packets at the ride registration desk
5. **Camping is very limited. Only 10 horse camping spots permitted for Friday night camping. Assigned in order of the entry date received. Must call for availability.**
6. No dogs allowed at ride briefings or in horse presentation area. Can be on leash at trailer only. This is a requirement from the ride insurance company. Please comply.

Please be sure your equine is up to date on vaccinations and deworming for everyone's safety. If you are crossing state lines, a current health certificate or Coggins is required.

Directions: From Interstate 80, take Hwy 49 exit (Elm St. exit 119C) toward Placerville. Turn LEFT on High Street and follow signs to Highway 49 South. Stay on Highway 49 South (it's a winding road) for 2 miles, then turn RIGHT at the bridge to Cool (4 miles). For those using GPS, use Saint Florian Dr., Cool, CA and it should take you there. The staging area is off Saint Florian Court behind the Cool Fire Station, Turn RIGHT on 7200 Saint Florian Court (It'll be ribboned and signed for you). **Do not stop at the State Parks Iron Ranger.** Turn LEFT at the second entrance and you'll be met by staff for your permits and parking instructions.

RIDER LIABILITY WAIVER

The following must be signed and dated for entry to be valid:

"I WISH to enter and participate in the Cool Canyon Leisure Division Competitive Trail Ride, to be held at Auburn State Recreation Area on October 15, 2022 (date)". "I HAVE READ the rules, conditions, and regulations of the event and will comply with them. I AGREE to abide by the rules of the North American Trail Ride Conference and the aforementioned ride. I UNDERSTAND that competitive riding is a high risk activity, which involves being in remote areas for extended periods of time, far from communications, transportation, and medical facilities; that these areas have many natural and/or man made hazards which ride management cannot anticipate, identify, modify, or eliminate; that horses can be excitable, difficult to control and unpredictable; that personal belongings can be damaged, lost, or stolen, and that accidents can happen to anyone at any time.

I AGREE to assume all risks associated with my participation in this activity, and I accept full responsibility for myself and the animal I am riding. As a condition precedent to my being allowed to participate in this activity, I agree that I WILL NOT SUE OR BRING ANY CLAIM AGAINST THE NORTH AMERICAN TRAIL RIDE CONFERENCE, ITS DIRECTORS AND/OR OFFICERS, RIDE MANAGEMENT, RIDE PERSONNEL, VOLUNTEERS, PROPERTY OWNERS WHERE EVENT TAKES PLACE, AND/OR ANY OTHER INDIVIDUAL MEMBERS THEREOF, (HEREAFTER REFERRED TO AS "THE RELEASED PARTIES") FOR ANY INJURY, ACCIDENT, DEATH AND/OR LOSS OF ANY KIND WHICH ARISES OUT OF THIS EVENT, AND WILL INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FROM ALL LIABILITY FOR SUCH INJURY, ACCIDENT, DEATH OR LOSS, EVEN IF SUCH INJURY, ACCIDENT, DEATH AND/OR LOSS ARISES FROM THE ALLEGED NEGLIGENCE OF THE RELEASED PARTIES. I FURTHER ACKNOWLEDGE THAT I HAVE READ AND UNDERSTAND THIS STATE'S EQUINE ACTIVITY LIABILITY ACT WARNING (IF APPLICABLE), A COPY OF WHICH IS ATTACHED HERETO AND INCORPORATED BY REFERENCE HEREIN. I HEREBY CERTIFY THAT MY HORSE IS NOT UNDER THE INFLUENCE OF MEDICATION AND WILL NOT BE TREATED WITH OR GIVEN ANY MEDICATION PROHIBITED BY NATRC™ RULES. I HEREBY GIVE PERMISSION TO THE NORTH AMERICAN TRAIL RIDE CONFERENCE OR THEIR DULY APPOINTED AGENT, TO TAKE ANY APPROPRIATE ACTION DEEMED NECESSARY TO CHECK FOR POSSIBLE ADMINISTRATION OF DRUGS TO MY HORSE."

Junior riders must wear an ASTM/SEI, Snell, or approved equal equestrian riding helmet at all times while mounted.

To the extent any dispute arises out of this agreement, the parties agree to submit said dispute to binding arbitration before a neutral arbitrator mutually selected by the parties, said arbitration to be conducted in accordance with the Rules of the American Arbitration Association. All such arbitrations shall be held in the county or district where NATRC National headquarters are located. If the prevailing party, NATRC shall be allowed to recover all costs and expenses incurred, including attorney's fees and costs. - (a) Propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- (b) The unpredictability of an equine’s reaction to sounds, sudden movement, unfamiliar objects, person, or other animals;
- (c) Hazards, including, but not limited to, surface or subsurface conditions;
- (d) A collision with another equine, another animal, a person, or an object;
- (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious.
