The purpose of this award is to provide participants with an opportunity to express themselves about the impact of horses and NATRC. And to encourage the development of excellence in the field of written expression. Region 1 reserves the right to publish or duplicate this essay.

Rules: The author must be a Region 1 member (Family membership is ok) under the age of 18 but does not have to be an active rider

- Must be an original essay written by the author with minimal assistance.
- Must be typed and double spaced in 12 pt font and be between 800 and 1000 words.
- Entries are limited to 1 essay per junior per year.
- The topic should be related from the writer's personal experience and should pertain to NATRC but is not limited to competition- it can be from experience at home or volunteering.

Judging Criteria:

- Originality, creativity and conciseness
- Correct grammar and spelling
- Pertains to the subject
- Holds the reader's attention
- Have clear and supporting details
- Pluses given for entertainment value

Entries are due December 15th and winners will be prior to but awarded at the Regional Convention.

Short biography of Catherine de la Cruz by Angie Meroshnekoff

Catherine had many strengths. At age 17 she was one of the first women accepted into Veterinary School at University of California at Davis but sadly she had to leave school before graduating due to a severe illness. Later in her life she earned several different degrees including a Masters in Anthropology. She was a well -respected dog breeder and judge as well as an artist. However, writing and riding were her great interests. She rode hunter / jumpers from a very young age while growing up in San Francisco and after marriage mostly rode whatever horse her daughters owned. Family duties kept her from riding at one point in her life and later full knee and hip replacements made that look like an impossibility. However, she wanted to try. So at age 71 she got back on a horse and re-learned how to ride. Just a few short years later, through the influence of her old friend Nancy Kasovich, she got her own horse - Lola. And at age 75 competed in her first NATRC ride. She finished and even got first place at the next one. Her distance riding competition days didn't last long but for the next decade she dedicated herself to helping out the trail rides in other ways, volunteering at the rides, helping with the secretarial work, fundraising and making awards.

Writing was also where she was at, both commercially and for a hobby. She was a newspaper reporter for the Petaluma Argus Courier and later editor of the Vineyard Press in Sonoma. Catherine was a prolific writer, publishing hundreds of articles on so many different subjects. She wrote and published a book on the history of the Petaluma Fire Department. Much of what has been published about dogs- especially guardian dogs was her writing.

There was of course so much more to her life, this is just an outline of who she was. She believed in the saying "Life is not a journey to the grave with the intention of arriving safely in a well-preserved body, but rather to skid in broadside, thoroughly used up, totally worn out, and loudly proclaiming, "Wow what a ride".

VALENTYNE DEMONSTRATES THAT SENIORS RULE AT COOL 2024

Horse's Honor is a horse rescue organization located in Grass Valley, CA. At the 2024 Cool NATRC ride they donated a \$100 gift certificate to be awarded to the most senior horse competing. This honor went to Valentyne, owned by Kay Leiberknecht and ridden by Rhiley Muller. Not only did Valentyne complete the ride, she and Rhiley placed first in the Junior division! Rhiley and Kay both provided some input on their experiences and some background for Valentyne.

From Rhiley Muller:

At the Cool Ride, we got lost, doing circles to find our way but Valentyne listened well. It was special to get to ride her because at 24, she's old. Her arthritis was OK without Bute the week before the ride, so we took her to Cool. She liked the arena a lot for its softness and for rolling privileges. It was a great surprise to get a prize for Tyne (pronounced Tiny- because she's our biggest horse!) being the oldest horse there. I checked if I can buy something online, but no, so I'm eager to drive over to Horse's Honor Tack Store to see if I can get a bridle or a blanket or shipping boots for Tyne.

From Kay Lieberknecht:

I was a farrier for a 70+ horse ranch where they were breeding horses of color-paints and appaloosas. They had four yearlings without color and they owed me \$2000, so they donated the yearlings who were all wild. The little bay filly was the calmest and smartest it seemed, so I took her to the Tapestry Ranch where I was the equine-assisted learning instructor for 8-12 year old kids in a therapeutic after-school program. The others I gentled and taught the basics, and sold them, with the money benefiting Tapestry.

At Tapestry she was named for the heart on her forehead, spelled uniquely-Valentyne. She became a good riding horse, but after three years there, I noticed through hard experience that she didn't innately like and care about the kids, thought of them as smaller animals to be disciplined by herself.

So I took her to my place, where it was easier to keep the bounciest of kids out of her sphere of influence. Young adult Kyle Jones hooked up with her for several years, teaching her discipline via many miles together.


Once Kyle was on her, waiting to start off in a parade, and a motorcycle suddenly backfired right behind her. Tyne went straight up off the ground with all fours, landed just to the right of where she'd been and stood like she had never moved. Kyle popped off and landed facing forward on both feet at once, just to Tyne's left and took a bow. Those who saw it must have thought it was planned.

About four years ago, Rhiley started coming up to the ranch with her sister but didn't want to ride. She led Tyne on the trails with us and they could keep up, even at the canter. By the time she ever got on the horse, over a year later, there was such a great relationship between them, that Valentyne has been better behaved than ever, even with other riders. Tyne doesn't think of trying to discipline kids anymore, but our dog has to watch out.

Thank you to Rhiley, Kay, Horse's Honor and of course Valentyne.

"TATE THE GREAT"...AN UNLIKELY STORY


A few weeks after Penny's first "magic session" with Tater, my good friend Valerie asked if I would like to meet her for a trail ride. I explained that I could only walk and that I was rehabbing my horse. We had the best time and Tater didn't take a wrong step. Valerie suggested that we keep riding together and make a goal of riding in a competitive trail ride in October. I thought she was crazy, but ride after ride and day after day, Tater improved. Valerie kept at me and I made it my "Pie in the Sky" goal to ride a horse that others may have given up on in April, in a 10-12 mile competitive trail ride in October.

We continued bodywork with Penny and specialty trimming (no shoes), I did her stretches and exercises, she wore her magnets and had IR treatments. I added top of the line joint supplements, MSM and 100x Equine's Osteo-Max. In September, she came off Equioxx and hasn't had it since! We trained and rode, she got Cavallo boots to cushion her from rocks, and we kept shooting for the goal. Suddenly, the date arrived! It was October and we were competing in the NATRC Cool Ride, in Cool, CA! I couldn't believe it! She was sound and hopefully ready! I have never been so nervous in my life! I knew there were judges and obstacles but I didn't even care. I didn't need to win, I didn't need to even make time...I just wanted to finish the distance with a sound horse, my horse, my soul horse.

As we left the start, I was nearly panicking. She felt off, she was super excited (something rarely seen in such a mellow horse) and wanting to move out with my friend's Arabian. I had this pit in my stomach, that after everything I had asked too much of her. Suddenly, I realized I just needed to let her go and get balanced, and sure enough she smoothed out into a glassy and sound gait! At the halfway pulse and respiration check, I was so nervous. Maybe she wouldn't be sound, maybe she wasn't fit enough, maybe they would pull her from the race! But to my utter amazement, she did great, hanging in there with Valerie's very fit and experienced Arabian...my little pudgy Morgan! I was so proud!

We headed into the last half of the race and I could not have been more proud of that plucky little horse and all that we had been through! As we crossed the river and headed up the hill, toward the last couple of miles, I already felt triumphant! In the last mile, Valerie said, "If we trot the last mile, we can actually make time!". What? That seemed unreal to me, that not only were we a mile from finishing but we might even finish on time! We were tired and sweaty but that good little mare picked up the trot and brought us home, just under the limit! We had done it! She passed her final soundness check! We didn't win...and yet we did! I have never felt such a "win" in my whole life!

Tater is not a champion by anyone else's standard. She is beautiful but not fancy, she doesn't have perfect



conformation but does have a perfect heart! The lesson is never give up on your horse. So many people told me to not spend the time, money, energy, or tears. To just retire her or breed her for her color. They said buy another horse. Tater is my heart horse, if I could never ride her again that wouldn't change, but she deserved more than me accepting her pain. She deserved to have me look and look to heal her pain, until we found the answer...even in the oddest of places. I have so many people to thank, who love Tater as I do, and helped us find the answer. My sister Becky's support in her care and transport to vets and farriers, Ariel - my wonderful vet, Hal the wonder farrier, Penny's magic hands, Valerie's encouragement and faith...and the NATRC for giving us the opportunity for the "Coolest" Ride!



SUMMARY OF MINUTES OF THE NATRC REGION 1 BOD MEETING—JANUARY 7, 2025

Call to Order: Meeting called to order at 7:08 by chairman, Stephanie. In attendance were Stephanie, Angie, Maria, Joyce, Erin, Dannan, Rachel, and Joe from the new board. Linda our newly retired treasurer and Lena, our new trail advocate were also in attendance. Donna was absent.

Secretary's Report: Joyce - Linda moved to approve the September 17^{th} minutes, seconded by Dannan. Motion passed.

Treasurer's Report: Linda - Current balance is \$19,962.82. Linda sent her reports via email, attached. We came out in better financial shape than expected, especially considering the high cost of plane fare to bring judges from other regions.

Some of the reports that the treasurer needs to complete were discussed. Linda said not hard but deadlines need to be kept track of and met. There is a CRT-1 end of year financial report that needs to be filled and is why she has done a financial report for each ride and for the convention. There are also 3 California forms and 1 Federal report to be done each year.

Joyce moved to accept the treasurer's report, Dannan seconded. Motion passed.

Physical Resource Coordinator: Linda - Linda sent email with her inventory of T-shirts, ribbons and other items attached. Discussed need to order NATRC T-shirts and new rider T-shirts, including number of each size, what colors we would like and costs. Angle has an account with 1 Ink and offered to place the order. Board agreed on grey and either blue or purple for the NATRC T-shirts and blue for new rider T-shirts. Dannan moved for Angle to use her discretion and place the order, seconded by Linda. Motion passed.

Maria showed us some bibs that she found on Amazon. Discussion followed on how many needed, what colors, what would work for different sizes, etc. Angie moved and Dannan seconded to authorize Maria to place an order and be reimbursed or work with treasurer for payment by Region 1. Motion passed

Maria moved to have Linda order ribbons for this year, Stephanie seconded. Motion passed.

Historian: Donna Stidolph - No report

Wonder Workers: Joyce Driggers – Have Eel River and Jackson Forest done. Jamie emailed me the volunteer list from RMS and will work on this week and get report for the Region 1 mini convention. Need to recognize workers at convention.

Points/Membership: Donna Stidolph – absent Jamie has suggested that we separate these responsibilities. Jamie has kept track of points and placings of riders for us as she also works with this for National.

Dannan has agreed to be Membership Chair. National sends out a new member list. Linda has been receiving this and sending out Welcome emails. She also adds new members to her email list to send out emails keeping the membership and other interested parties informed of our current events and news. Dannan has agreed to take on this job. Linda will send her a copy of the email letter she has been using. Angie will notify National to begin sending new member information to Dannan.

Publicity/Outreach Coordinator: Linda – Linda will continue in this capacity for now.

The Leadline: Jo - Stephanie will get Jo's email information and pass it on to us, so we can add her to our list of people to attend our board meetings. Jo told Stephanie that she was going to set up a separate email for NATRC use so they would not get lost. Linda had a couple riders that wrote articles that could be used.

Also discussed was the frequency of the Leadline publication. Angie did it about every two months. It is up to the person doing it but would like it to be at least 4 times a year.

National BOD: Angie and Maria - the proposal to make the elimination of the weight divisions permanent was discussed. It was agreed that this should be done so the National BOD is not having to vote on it each year. If it was ever decided that they should be brought back, it can always be reinstated.

The national board was also discussing some items that did not need to be in the rule book as they are addressed in other forms. There was also a proposal that would clarify the timing for a ride timer to notify the ride manager of time penalties.

Region 1 Website: Donna Stidolph - not present — Linda will contact Donna to see about getting the website updated and see if she wishes to continue in this capacity. The board suggested that she might also volunteer as one of our official ride photographers.

SUMMARY OF MINUTES OF BOD—CONTINUED

Lena expressed an interest in becoming our Website manager, if it was needed. She will look into and report on the cost of SquareSpace which she has used in the past.

Ride/Clinic Management: Jamie says Maria is listed in this position on the National Website. Angie said she is our ride/clinic liaison between our region and national

Mt. Diablo 5/3 – The CMDTRA will be putting on a LeD ride again this year with a new trail master. Shouldn't be a problem as their trails are pretty well established.

Cowboy Camp – Date set for 5/31-6/1. Linda has sent in application with our date to BLM. Our date was changed as AERC took our date due to weather issues in early May. Then they did not change their date but did not communicate with us. Still in need of a ride manager. Linda will put out an email asking if anyone is willing to step forward and do this. Angle has put out requests for judges. She is waiting for replies.

Eel River 6/14-15. Road is reopened. Lots of trail clearing will need to be done. Angie has judges.

Jackson Forest 8/23-24. Linda has been in contact with Whitney and Robin and is helping them with deadlines etc.

Cool Canyon 10/11 Erin is again putting it on. Linda said Carol said that she would be interested in vetting 2 rides this year. She is already doing Eel River. Angie will see if she would be willing to do Cool also.

Trail Advocacy Coordinator: Lena Scaramuzzo – no report at this time. Discussion ensued – fee to join Back Country Horsemen is around \$40/annually. Dannan will send Randy Hackman's (with Back Country) contact information to Lena. Erin is on the board with the Georgetown association that manages Dru Barner. They have a meeting next week. Erin has been thinking about trying to put on a NATRC ride there. Angie said that NATRC National has funds for grants to help with trail maintenance in the amount of \$500. Something to be aware off. We will put Lena in touch with the Highlands Springs group. They have expressed an interest in putting on a NATRC ride. We need to put on our website and Facebook page about Lena being our trail advocate and information can be sent to her.

New Business:



- 2) Angie moved that Region 1 pays our share of vet judges' dues. Maria seconded, motion passed.
- 3) Discussed increasing ride fees due to increased costs, especially the drug fee. Angle said fees have always been up to the ride manager, but now Region 1 puts on all our rides except Mt. Diablo. It was proposed to add a separate line for drug fee, which is \$14 per horse entered. The consensus was to just up the fees enough to cover this. Also discussed the PayPal fees that the Region has been absorbing.
- 4) Election of Officers. Angie nominated Erin for Chair. Stephanie seconded. Erin accepted and board voted her in. Angie nominated Joyce to continue as Secretary and Maria seconded. Joyce accepted and board voted her in. A new treasurer is needed. Asked for volunteers. After a little discussion, Rachel stepped up. Erin moved to nominate Rachel and Dannan seconded. The board voted her in.

TRAIL ADVOCACY
