



Cool Canyon NATRC Ride:

B1 (Sat) Oct 10, O/N/CP/Leisure

B2(Sun) Oct.11, O/N/CP/Leisure and the 2026 AHA Championship for Region 3 .

**Rider limit = 25 O/CP/N and 25 Leisure each day
Auburn State Recreation Area, Cool, California**

Ride single track and fire roads through the heart of historic Gold Country outside of Auburn, CA. The ride is sanctioned by the North American Trail Ride Conference (NATRC) and will be conducted under NATRC rules as published in the 2026 NATRC Rule Book (available online at natrc.org). All riders will stage out of Cool Hills Ranch (3320 State Hwy 49, Cool, CA 95614), a private facility close to the Cool Equestrian Staging Area in Cool, CA.

Leisure Riders may camp over Friday and/or Saturday nights or choose to arrive Saturday or Sunday morning, early enough to attend the ride briefing and morning check in for their horse.

B1 (Sat) Open, Novice, CP Riders: please arrive no later than 3 pm Friday for the Friday afternoon check-in. *If you're arriving late, notify ride management.* Park in designated parking spots as directed. Parking will be assigned by rig size due to limited camping space), include your full rig length (truck+trailer) on your registration form. **Try to share your trailer with a friend to save space** **Priority will be given to those with multiple horses in their trailers.** B2 (Sun) O/N/CP riders, arrive by 3 PM Saturday for Saturday check-in. If you are riding both days, you will check in for EACH ride as they are considered separate rides.

To qualify for the AHA (Arabian Horse Association) ride you must: 1) be a current competition member with AHA, 2) your horse must be an Arabian or half Arabian 3) you must have completed a minimum of 50 or more competitive miles: 25 miles from NATRC or AHA CTR and the other 25 miles can be from Limited Distance AERC rides or any other endurance distance 25 miles or greater 4. **Submit your AHA membership number, horse's full registered name and registration number.**

- **Open Division** (Adult and Junior classes): Timed for a well-conditioned horse that can trot evenly on the flat and walk fast up down hills. 25-30 miles/ Sat and Sun. Pace=4-6 mph. Pace varies with terrain with an average pace of 5+ mph. Equines must be 5 years or older. **Open is the only division that qualifies for the Sunday AHA Championship Ride. Saturday's Open ride will count as a last minute qualifier.**
- **Competitive Pleasure** (CP) (Adult and Junior classes): timed for experienced competitors who are no longer eligible for or choose not to compete in the Novice Division but do not wish to advance to the faster pace and distance of Open. Timed for a brisk walk with some trotting. Equines must be 4 years of age or older. 18-22 miles for both Sat. and Sun. rides. Pace=3.5-5.0 mph. Pace varies with terrain with an average pace of 4.5 mph.
- **Novice** (Adult and Junior classes): same mileage and pace as Competitive Pleasure. Equines must be 4 years of age or older.
- **Leisure Division:** Adult, Junior and Experienced classes. Equines must be 4 years of age or older. ~10-12 miles for both Sat and Sun rides. The pace is 3-4.5 mph. Pace varies with terrain with an average pace of 4.0 mph.

Cancellations: Entry fee refunded except for a \$40.00 administrative fee when received by October 2nd. Management may approve late cancellations if due to medical issues or extenuating circumstances. Contact ride management to discuss. No refund if you are a No show.

No refund if equine does not pass the pre-ride exam, all divisions.

Ride Management reserves the right to refuse an entry.

Registration is NOT complete until NATRC, CA and Cool Hills Ranch waivers are signed and provided to management along with payment. Mail signed waivers with registration forms or if registering via RMS, mail the waivers to ride management and submit payment prior to the ride or make arrangements to bring the signed waivers with you to the ride. Pay Pal is available for on-line payments and is also an option when using RMS (it's on the pull-down menu, payment page).

Please read. You are in competition from the time you present your horse at check-in until check-back upon completion of the ride.

1. A saddle with stirrups is required but there are no restrictions as to type.
2. In camp, horses will be trailer tied in accordance with NATRC rules. High Ties are OK. S o r r y - No room for portable corrals. After 10pm-QUIET time. Stallions must be double tied and only ridden by an adult.
3. Water is available for horses. Bring your own people water. Hay not available for purchase.(feed store nearby)
4. **All juniors under 18 are required to wear an ASTM/SEI, Snell or approved riding helmet at all times when mounted. Minors must be accompanied by an adult in camp. NATRC Riders 8-12 yrs must ride with an adult sponsor or a junior sponsor 13 or older with 250 NATRC miles. .AHA CTR Jrs 16 and under MUST have an adult sponsor 21 yrs or older. Management strongly suggests that all juniors be accompanied by an adult on the trail.**
5. **All juniors must have a liability waiver signed by a parent or legal guardian. Return signed waiver with entry by mail or bring to the ride. Juniors cannot ride without the signed waivers. No exceptions. Junior waiver form must list sponsor's name and phone number.**
6. RIDERS AND VOLUNTEERS MUST SIGN all Liability Waiver(s) to participate in this ride.
7. Camping is at a Cool Hills ranch. Space is limited.. Priority given to rigs with 2 or more horses. Call or text Christine Grey for updated camping availability. Camping fees are listed are PER RIG, NOT per horse.
8. **Make sure your equine is up to date on vaccinations and deworming for everyone's safety.**
9. ****Note that Cool Hills Ranch is a private boarding facility and the owner has requested no dogs allowed at this event for the safety of her boarders. Please comply if you are camping or parking at Cool Hills Ranch. ****

Ride Notes:

As this is the last Region 1 Open ride for 2026, the multi-day option enables riders to qualify for the 2026 AHA Championship, 2026 Region 1 end of year awards and 2026 NATRC National awards.

1. The one day Open ride Sat. (B1) can be used to qualify for the AHA Championship Ride on Sun.
2. **Region 1 end of year awards require a minimum of two rides completed and National end of year awards require a minimum of 3 rides completed. To provide additional qualifying rides, Cool Canyon is offering two ONE DAY rides. If you choose to ride both the B1 and B2 O/N/CP rides, a two-day discount is offered to help make it comparable to an A ride. NATRC membership is required to qualify for end of year awards.**
3. **Drug Testing:** *(Note: all competitive rides are subject to random drug testing by the State of California. They may collect either blood or urine specimens. Ride entry denotes agreement to State testing.)*
4. Water at the P&R's will be available in communal troughs or via a dipping bucket from a "clean" trough (recommended). Bring your own collapsable bucket if you prefer to use the "clean trough water". Cannot guarantee that the creeks will have water at this time of year.

Directions:

To Cool Hills Ranch: From Interstate 80, take Hwy 49 exit (Elm St. exit 119C) toward Placerville. Turn LEFT on High Street and follow signs to Highway 49 South. Stay on Highway 49 South (it's a winding road) for 2 miles, then turn RIGHT at the bridge to Cool (4 miles). Proceed to stop sign, go straight ~3/4 mile. Barn/facility entrance on the right (look for covered arena) Watch for the pink/yellow ribbons indicating the turn into Cool Hills Ranch.

To Cool Hills Ranch: From Hwy 50 (better for large rigs)** take Exit #37 Ponderosa/Shingle Springs. (The freeway exit is labelled with the street name but may not have "Exit #37" written on it)

(From Hwy 50 West, go left over the freeway. From Hwy 50 East, go right over the freeway). The first RIGHT once you cross over the freeway is N. Shingles Springs Rd. Continue on this two-lane road until you reach Lotus where it will dead end into Hwy 49. Turn Left on Hwy 49. Continue 12 miles to Cool. Cool Hills Ranch will be on the left, just past Northside School and Cool Church. Use second entrance by the covered arena. Watch for the pink/yellow ribbons indicating the turn into Cool Hills Ranch.

Volunteers: day parking fees for Cool Hills Ranch will be paid by Cool ride management. Pick up a parking voucher at the registration desk and make sure it's visible in your vehicle window.

There will be a Camp Schedule sent out to all riders and volunteers approximately 5 DAYS before the ride. **We encourage all riders to stay for awards and join in the Pot Luck Dinner Friday and Catered Dinner Saturday.**

The FATTRAC bicycle club will again be assisting us on the trail both as safety volunteers and checking ribbons. Please welcome them.

Awards will be presented each day as soon as results are available. AHA awards as well as NATRC awards/ribbons will be presented Sunday. If you must leave prior to awards, please notify ride management.

A Silent Auction will be held on Saturday afternoon as a fund raiser.

RIDER LIABILITY WAIVER

The following must be signed and dated for entry to be valid:

"I WISH to enter and participate in the Cool Canyon NATRC Competitive Trail Ride, to be held at Auburn State Recreation Area on October 10-11, 2026. "I HAVE READ the rules, conditions, and regulations of the event and will comply with them. I AGREE to abide by the rules of the North American Trail Ride Conference and the aforementioned ride. I UNDERSTAND that competitive riding is a high risk activity, which involves being in remote areas for extended periods of time, far from communications, transportation, and medical facilities; that these areas have many natural and/or man-made hazards which ride management cannot anticipate, identify, modify, or eliminate; that horses can be excitable, difficult to control and unpredictable; that personal belongings can be damaged, lost, or stolen, and that accidents can happen to anyone at any time.

I AGREE to assume all risks associated with my participation in this activity, and I accept full responsibility for myself and the animal I am riding. As a condition precedent to my being allowed to participate in this activity, I agree that I WILL NOT SUE OR BRING ANY CLAIM AGAINST THE NORTH AMERICAN TRAIL RIDE CONFERENCE, ITS DIRECTORS AND/OR OFFICERS, RIDE MANAGEMENT, RIDE PERSONNEL, VOLUNTEERS, PROPERTY OWNERS WHERE EVENT TAKES PLACE, AND/OR ANY OTHER INDIVIDUAL MEMBERS THEREOF, (HEREAFTER REFERRED TO AS "THE RELEASED PARTIES") FOR ANY INJURY, ACCIDENT, DEATH AND/OR LOSS OF ANY KIND WHICH ARISES OUT OF THIS EVENT, AND WILL INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FROM ALL LIABILITY FOR SUCH INJURY, ACCIDENT, DEATH OR LOSS, EVEN IF SUCH INJURY, ACCIDENT, DEATH AND/OR LOSS ARISES FROM THE ALLEGED NEGLIGENCE OF THE RELEASED PARTIES. Junior riders must wear an ASTM/SEI, Snell, or approved equal equestrian riding helmet at all times while mounted.

To the extent any dispute arises out of this agreement, the parties agree to submit said dispute to binding arbitration before a neutral arbitrator mutually selected by the parties, said arbitration to be conducted in accordance with the Rules of the American Arbitration Association. All such arbitrations shall be held in the county or district where NATRC National headquarters are located. If the prevailing party, NATRC shall be allowed to recover all costs and expenses incurred, including attorney's fees and costs. Hereinafter referred to as "I" and Cool Hills Ranch, hereinafter referred to as "Cool Hills Ranch" of 3320 Hwy 49, Cool, CA 95614.

It is hereby agreed to as follows:

1. **HAZARDOUS ACTIVITY:** I understand that horseback riding is a hazardous activity and that horses are unpredictable by nature; that when frightened or angry or under stress, a horse's natural instincts are to jump forward or sideways, to run away from danger at a trot, canter, or gallop, to kick, to buck, to rear up in front, or to bite; that horses are extremely powerful; and that if a rider falls to the ground, the fall distance will generally be more than 5 feet. I understand that these risks and voluntarily assume these risks and dangers for myself or on behalf of my child or legal ward. I further expressly agree that the forgoing release, waiver, and indemnity agreement are intended to be as broad and inclusive as is permitted by law of the State of California and if any portion thereof is held invalid it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. _____(Initial here)
2. **RIDING HELMETS:** I understand that I can better protect myself against head injuries by wearing protective equestrian head gear while mounting, riding, dismounting and being around horses. I accept full responsibility for the increased risk of injury if I decide not to wear a helmet or not to require my child or legal ward to wear a helmet. _____(Initial here)
3. **LIABILITY RELEASE:** I understand that, except in the event of Cool Hills Ranch wanton or willful negligence, I am responsible for bodily injury or property damage that I or my child or legal ward should sustain while riding a horse. I am also responsible for medical expenses or any other expense incurred as a result of such bodily injury or property damage. I am responsible for any time I, or my child or legal ward shall lose in employment or school or other activity. I hereby for myself, my heirs, administrators and assigns release and discharge Cool Hills Ranch (John and Cristine Grey) from claims, demands, actions, and causes of action for such injuries sustained to my person, or that of my child or legal ward and/or my property. _(Initial here)
4. **INDEMNITY:** I hereby agree to indemnify, save and hold harmless, each of them from loss, liability, damage pay any expenses, loss or damage that is incurred due to my participation I said instruction, training, riding, handling, leading, Veterinary assistant of personal horse or other horses and Ferrier assistant whether caused by negligence of release or otherwise by Cool Hills Ranch. _____(Initial here)
